## Invitation to Bid for the Supply and Delivery of kWhr Meters, 5(100) A, Electronic, Single Phase, Bottom Connected (6,434 units)

### ITB No. 2409, S. 2024

1. The Iloilo III Electric Cooperative, Inc., through the 2024 Locally Funded Project – Total Electrification Project (2024 LFP-TEP) intends to apply the sum of Ten Million Two Hundred Ninety Four Thousand Four Hundred Pesos (PhP 10,294,400.00) being the Approved Budget for the Contract (ABC) to payments under the contract for ITB No. 2409, S. 2024 - Supply and Delivery of kWhr Meters, 5(100) A, Electronic, Single Phase, Bottom Connected (6,434 units). Bids received in excess of the ABC shall be automatically rejected at bid opening.
  2. The Iloilo III Electric Cooperative, Inc. now invites bids for the above Procurement Project. Completion of the Works is required Sixty (60) Calendar Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
  3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  4. Interested bidders may obtain further information from Iloilo III Electric Cooperative, Inc. (ILECO III) – Bids and Awards Committee, at ILECO III Main Office, Brgy. Preciosa, Sara, Iloilo and inspect the Bidding Documents at the address given below from 8:00AM to 5:00PM.
  5. Prospective bidders must submit a Letter of Intent indicating the Authorized Representative/s, official email address and contact number, duly supported by a Notarized Authorization letter and one (1) valid ID to whom all transactions pertaining to the bidding shall be communicated by the ILECO III BAC.
  6. A complete set of Bidding Documents may be acquired by interested bidders on October 21, 2024 from the given address and website/s below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty Five Thousand Pesos (PhP 25,000.00)*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person or through email*.
- It may also be downloaded free of charge from the website of the National Electrification Administration (NEA) and the website of ILECO III, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
7. The Iloilo III Electric Cooperative, Inc. will hold a Pre-Bid Conference<sup>1</sup> on October 29, 2024 at the ILECO III Boardroom, Brgy. Preciosa, Sara, Iloilo, at 1:30 PM, which shall be open to prospective bidders.
  8. Bids must be duly received by the BAC Secretariat through manual submission at ILECO III Boardroom, Brgy. Preciosa, Sara, Iloilo. Late bids shall not be accepted.
  9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.
