Invitation to Bid for the Design, Supply, Delivery, Construction and Installation of Receiving and Sending Facilities of Three (3) Islands for Nine (9) Barangays (Turn Key)

ITB No. 2503, S. 2025

1. The *Iloilo III Electric Cooperative, Inc.*, through the *NEA 2011-2022 Subsidy Savings* intends to apply the sum of *Thirty One Million Two Hundred Seventy Five Thousand Pesos (PhP 31,275,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for *ITB No. 2503, S. 2025 - Design, Supply, Delivery, Construction and Installation of Receiving and Sending Facilities of Three (3) Islands for Nine (9) Barangays (Turn Key)*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Iloilo III Electric Cooperative, Inc.* now invites bids for the above Procurement Project. Completion of the Works is required *One Hundred Seventy (170) Calendar Days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *Iloilo III Electric Cooperative, Inc. (ILECO III) – Bids and Awards Committee, at ILECO III Main Office, Brgy. Preciosa, Sara, Iloilo* and inspect the Bidding Documents at the address given below from *8:00AM to 5:00PM*.
5. Prospective bidders must submit a Letter of Intent indicating the Authorized Representative/s, official email address and contact number, duly supported by a Notarized Authorization letter and one (1) valid ID to whom all transactions pertaining to the bidding shall be communicated by the ILECO III BAC.
6. A complete set of Bidding Documents may be acquired by interested bidders on January 13, 2025 from the given address and website/s below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty Five Thousand Pesos (PhP 25,000.00)*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person or through email*.

It may also be downloaded free of charge from the website of the National Electrification Administration (NEA) and the website of ILECO III, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

7. The *Iloilo III Electric Cooperative, Inc.* will hold a Pre-Bid Conference¹ on *January 21, 2025* at the *ILECO III Boardroom, Brgy. Preciosa, Sara, Iloilo, at 2:00PM*, which shall be open to prospective bidders.
8. Bids must be duly received by the BAC Secretariat through manual submission at ILECO III Boardroom, Brgy. Preciosa, Sara, Iloilo. Late bids shall not be accepted.
9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.
